ANNUAL REPORT FISCAL YEAR 2019

For the Martin Luther King, Jr. Day of Service 2020, UCP Seguin of Greater Chicago commemorated the life of Dr. King and reflected on his dream for equality and civil rights for all people. We recognize that the iconic civil rights leader's passionate and persistent fight for equality and against discrimination paved the way for the disability community to advance and persevere in its ongoing fight for equality, rights, and inclusion.



On Saturday January 18th UCP Seguin made it a day on, not a day off! Volunteers with intellectual and developmental disabilities worked alongside volunteers without disabilities to help children and adults in our community who experience challenges accessing food and struggle with food insecurity.

Student volunteers and staff from Glen Crest Middle School in Glen Ellyn and Lincoln Middle School in Berwyn joined people with disabilities served by UCP Seguin of Greater Chicago, assembling over 350 nutritious Breakfast Bags that were then distributed to the Midwest Shelter for Homeless Veterans and other Homeless Veterans organizations. The volunteers also filled over 350 weekend backpacks with nutritious food for weekend meals for students experiencing food insecurity. At the conclusion of the service project, the volunteers gathered for lunch and received a bowl they designed at the volunteer kick-off in November.

Staff from the UCP Seguin Food Hub, Day Program and Seguin Gardens & Gifts organized and led the MLK Day of Service effort, helping to secure the food, oversee the creation of special ceramic bowls, and provide enthusiastic engagement with project volunteers.

"People with disabilities are often perceived as the ones always in need of help, but in reality, they also have the desire and ability to help others and to play an active role in strengthening their own communities," said John Voit President/CEO of UCP Seguin. "In the true spirit of Dr. King, the Day of Service shines a light on what all people – including those with intellectual and developmental disabilities – can do to love, uplift, and support their neighbors."

The Corporation for National and Community Service, the federal agency that leads MLK Day of Service, selected The Arc – a national advocacy organization of which UCP Seguin is a chapter – and a small group of other organizations to plan and participate in volunteer projects that help unite communities across the nation. UCP Seguin then received a grant through the auspices of The Arc to help underwrite costs associated with this project.

The Arc advocates for and serves people with intellectual and developmental disabilities (I/DD), including Down syndrome, autism, Fetal Alcohol Spectrum Disorders, cerebral palsy and other diagnoses. The Arc has a network of over 600 chapters (including UCP Seguin) across the country promoting and protecting the human rights of people with I/DD and actively supporting their full inclusion and participation in the community throughout their lifetimes and without regard to diagnosis.

THEY DESERVE MORE RETURNS TO ACTION

UCP Seguin Again in Major Role with Statewide Advocacy for People with Disabilities...and Their Dedicated Caregivers

The **They Deserve More** Coalition – for which UCP Seguin plays a major role – is reactivating its efforts to push for legislation to secure a living wage for Direct Support Professionals (DSPs) and help people with intellectual and developmental disabilities get the support and care they need!

While our efforts over the last three years have achieved some small steps in the right direction, DSPs still earn woefully inadequate wages, which has caused a staffing crisis in Illinois as many of them leave for better paying jobs. The state meets other obligations – funding jails and skilled nursing and schools – why is it leaving people with disabilities behind?


Since 2017, They Deserve More has succeeded in raising the state wage reimbursement for most DSPs from \$10.71 an hour to \$12.38 an hour and securing the first slight cost-of-doing-business increase in 11 years for programs for people with disabilities. We await final federal approval for the State's proposed DSP wage reimbursement increase to \$13 an hour, which could become effective back to January 1. Unfortunately, these appreciated but modest steps don't come close to meeting the need. We urge the General Assembly to increase state funding for people with disabilities by 20%—with 75% of this increase dedicated to DSP wage reimbursements. People with disabilities deserve more.

There are now two bills – HB 5074 and SB 3269 – filed in the Illinois General Assembly that would solve Illinois' DSP staffing crisis and secure adequate funding for nonprofit agencies.

HOME IS WHERE THE HEART UCP Seguin Families Put Their Hearts into Raising Resources for the Cause

Three years ago, UCP Seguin was looking at major financial challenges due to longstanding shortfalls of funding by the State of Illinois for services to people with developmental disabilities. We made many hard decisions, cut costs, aggressively sought additional revenues, and reworked our budget. UCP Seguin led the formation of the They Deserve More Coalition, to jointly advocate along with dozens of other organizations for additional funding from the state to address the turnover and vacancy staffing crisis in our services. But at the heart of UCP Seguin's efforts was generating crucial support from families and friends.

In the fall of 2018 UCP Seguin initiated the Hearts, Homes, Family (HHF) appeal,

encouraging family members of persons served to help in meeting the significant financial challenges we were facing. Our goal: raise additional dollars from families, both through direct gifts from family members and through donations from their additional families and friends. The results were impressive. In FY2019 several hundred families and friends contributed almost \$180,000 to the HHF campaign – a nearly 57% increase from the previous year.

Families also engaged in legislative advocacy through the They Deserve More campaign, urging state legislators to increase funding to recruit and retain Direct Support Professionals (DSPs) through higher wage reimbursements, and to address longstanding operational costs. This effort – in conjunction with advocacy from people across Illinois – resulted in a 3.5% cost of living increase for the current FY2020.


The Hearts Homes Families campaign continues anew this year, as does They Deserve More. Once again UCP Seguin urges families of persons served and their friends to give personally, and to ask others to contribute too. Through two-thirds of the fiscal year the HHF campaign has raised nearly 70% of the \$210,000 goal. But with little time left in this fiscal year, we have approximately \$63,500 to raise to meet this

lofty outcome.

SPECIAL VISITOR SHEDS LIGHT ON FOUNDING OF UCP SEGUIN

Mary Brigitte Brozovsky Wiebelt Waxes Poetic about 70 Years of Pioneering Services to People with Developmental Disabilities

In the fall of 2019 UCP Seguin welcomed an extra special visitor from its original founding some 70 years ago. Having returned to Chicago for her high school reunion, Mary "Brigitte" Brozovsky Wiebelt graciously made a point of checking in with an organization that meant so much to her and her family. Brigitte is the last surviving member of her family and the younger sister of Bonnie Brozovsky, one of the first students at the original "Seguin School" which was founded in 1949. On her visit Brigitte toured our Seguin Gardens & Gifts and Seguin Auto Center social enterprises, talking with UCP Seguin's staff to learn all she could about what we are doing for people with developmental disabilities, some seventy years after her sister began her stint at this innovative organization. UCP SEGUIN FOOD HUB -A CORNUCOPIA OF PROVISIONS!

Partnership with Greater Chicago Food Depository Provides Much-Needed Food for UCP Seguin Participants





What started out as random donations of bread and pastries from a local Costco has become an essential new endeavor – the UCP Seguin Food Hub. The Food Hub was developed to provide healthy and plentiful food to the individuals served in our residential group homes, intermittent support sites, home-based services, and children's foster care. The intrepid staff from the Seguin Auto Center saw a need and most importantly, saw an opportunity. They pursued a partnership with the Greater Chicago Food Depository (GCFD) to open an affiliated program for UCP Seguin of Greater Chicago.

Located on the first floor of the 3150 S. Central Avenue building in Cicero, next to our Carr Center headquarters, the UCP Seguin Food Hub opened for business in April of 2019. It is available to all participants who live independently, with their families, in an adult foster parent or shift-staffed home, or are in the Children's Foster Care program. The participants are able to come to the Food Hub and "shop" to select food, which focuses on healthy products that match with healthy lifestyles we are promoting.

The Food Hub is always full of fresh produce, chicken, ground turkey, ground beef, a variety of breads & cereals, brown rice, beans & lentils, and a wide assortment of canned goods. Donations are procured from the Greater Chicago Food Depository bi-weekly as well as through weekly donations from three local Aldi's and two Target stores. These donations result in a bountiful "horn of plenty": an average of 9,400 lbs of healthy food each month for persons with disabilities served by UCP Seguin.

The Food Hub is a wonderful resource for the UCP Seguin community that will continue to grow and prosper, benefitting even more participants and their families. "I would imagine that each person involved with UCP Seguin of Greater Chicago could wax poetic about the opportunities and benefits this organization provides," said Brigitte. She was pleased to find that UCP Seguin is bigger and better than ever. She saw the same basic ingenuity and can-do spirit displayed at Seguin Gardens & Gifts and Seguin Auto Center that she had witnessed as a child in the 1950s when she visited the Seguin School as the organization was then called. And we at UCP Seguin were enthused to hear all she had to tell us about the history of our own organization's beginnings.

After her visit, Brigitte wrote to us in more detail about her own family's involvement in the origins of UCP Seguin. Her parents Helen and Bernard Brozovsky "found themselves searching for help, advice, and a life for Brigitte's oldest sister Bonnie when she was born in 1942 with a developmental disability." Back then, as Brigitte related, there was no such assistance for children with disabilities. Her parents became part of a handful of parents who started to meet, talk, educate themselves and dream of what could be for their children. She explained about the naming the school (after 19th century educator and psychiatrist Edouard Seguin). These Seguin "Pioneer Parents" put their dreams to reality by founding, then growing, the first Illinois school for children with developmental disabilities. 

S THINGS TO KNOW:The Secure Act May Change Your Retirement Planning

Last year, the Secure Act was signed into law and it made several changes that may impact your retirement planning. The Act took effect January 1, 2020.

- The Act pushes back the age at which retirement plan participants need to take required minimum distributions (RMDs), from 701/2 to 72.*
- The Act allows traditional IRA owners to continue contributing to IRAs indefinitely if your income is below the threshold of \$137,000 for single taxpayers and \$203,000 for married filing jointly.
- Non-spousal inherited retirement account RMDs must now be taken within 10 years of inheriting the retirement account individuals who inherited an IRA previously could stretch out the distribution over their estimated lifetime. This will potentially boost the tax burden these payments will cause.
- Long-term part-time employees will now be eligible for 401(k) plans they must work 500 hours or more per year.
- The Act allows 401(k) plans to offer annuities.
- * You can save money by asking your broker to distribute a portion of your RMD directly to UCP Seguin of Greater Chicago (FEIN 36-2894174). This distribution is still credited as part of your RMD, but it is not counted as taxable income to you. Therefore, it is less costly to you to use your RMD dollars to make your philanthropic contributions.
