While most of us enjoy the seasonal bounty of gifts and camaraderie, many individuals with disabilities served by Seguin have no family able to be with them and support them during the winter holidays. Recognizing this situation, nearly 100 "Secret Santas" – including Seguin staff, Board, and members of the Seguin community – banded together to bring holiday joy to these many individuals.



For at least the last decade, Seguin has conducted a "Secret Santa" campaign to ensure all of our participants enjoy the benefits of the holiday season. This year was especially important because nearly twenty new residents have come to live in Seguin group homes and many have little to no family support.

Altogether the "Secret Santas" provided an abundance of gifts to 116 Seguin participants, based on each individual's "wish-list". Of note is that nearly three-quarters of the donors were staff members. This signifies how committed Seguin employees are to our mission, as they generously enrich the lives of these participants during the holiday season – and throughout the rest of the year as well. In addition, our Board members, other participants' family members, and community

members from far and wide rose to the challenge of bestowing kindness during one of the busiest and most stressful times of year.

You can imagine how Seguin participants responded to their holiday offerings. Each individual expressed, however they were able, the excitement and happiness of receiving their new treasures, from new clothes to jewelry, from a karaoke player to Elvis Presley CDs and movies, from board games to PlayStation 2, and more...treasures only made possible due to the outstanding generosity of exceptionally generous individuals.

## Presidents' Corner

Dear Friend of Seguin,

We are pleased to share with our Seguin Services supporters some very good news about the long-term growth and viability of our organization: Seguin Services' Board of Directors has signed a letter of intent to merge with United Cerebral Palsy (UCP) of Greater Chicago effective July 1, 2013.

John Voit, Seguin's President and CEO since 1998, will become president of the new organization. Paul Dulle, PhD, President and CEO of UCP of Greater Chicago since 1993, will provide ongoing consulting to the new organization and will serve as chairman of a new foundation under consideration by both organizations.

Recognizing inherent synergies between our organizations, Seguin and UCP have been working together for three years on a number of programs including a life-skills training program for individuals served from both agencies, consolidations of employment programs and construction of a new residential group home in Lombard.

With this planned merger, UCP-Seguin of Greater Chicago will share competencies, expertise and resources while achieving greater operational efficiencies and reduced costs. Most importantly, the new organization will be well-positioned to provide more and better programs and services to help people with disabilities reach their full potential and play a valued, vital role in community life.

Please note that this planned merger will not affect the programs and services Seguin and UCP are currently providing. Seguin and UCP are both strong organizations, and we plan to retain all staff under the new arrangement.

We have much work to do to ensure a smooth transition before the merger becomes final, and we will keep you abreast of our progress as we move forward.

## Another Year of Innovation & Growth...

- Seguin Community Integrated Living Arrangement group homes expanded to meet community need, with more than 240 individuals served by end of 2012, including several former residents from Jacksonville Developmental Center successfully transitioning into community settings
- 248 Seguin participants were in paid jobs
- More than 765 special education students assisted in transition to adulthood through Seguin-led Building Bridges to the Future initiative, with expansion continuing in 2013
- 38 foster children achieved permanency – through either adoption, guardianship or return to family – in past year
- Seguin CLIMB day services program in Du Page County expanded to serve 20 individuals with developmental disabilities
- Seguin & UCP of Greater Chicago expanded partnership, joining forces to secure employment and provide job supports for people with disabilities, while continuing to implement “New Directions” curriculum for day services
- Continued expansion of SeguinCares homes to serve seniors with age-related conditions
- Seguin Enterprises efforts continued to see return on investment, with increased sales at Seguin Gardens & Gifts and 50 participants per week receiving Horticulture Therapy

## SOCIAL SECURITY:

Best time to make your claim...  
and benefit your loved one with a disability

Are you approaching your 62nd birthday? Do you have a son or a daughter with a disability? The time you decide to begin collecting Social Security benefits will impact your level of benefits...and also the benefits your child with a disability receives.

### Here are some key points to consider:

- When you begin collecting Social Security, your child with a disability, as qualified by Social Security rules, will begin receiving a benefit up to  $\frac{1}{2}$  the value of your Social Security benefit.
- If you choose to begin collecting Social Security at age 62, you will receive 80% of the amount you would have received if you waited till age 66 to begin collecting Social Security. Your child with a disability will receive a benefit up to  $\frac{1}{2}$  the value of your earnings.
- An earnings cap is imposed on individuals who choose to claim Social Security at age 62. If you earn more than the cap, your Social Security will be reduced by \$1 for every \$2 you earn over a specified limit or cap. In 2013, the limit is \$15,120.
- Individuals who file for Social Security at age 66 will receive their full Social Security benefits (for those born between 1943 and 1954). Your child with a disability will receive up to  $\frac{1}{2}$  the value of your benefit.
- For every year over age 66 up to age 70 in which you delay receipt of Social Security benefits, you will receive an additional 8% increase in the value of your benefit. The amount of increase depends on your birth year. Your child will receive a benefit up to  $\frac{1}{2}$  the value of your benefit, including the increase.
- Once you pass away, your child with a disability will begin receiving a benefit equal to  $\frac{3}{4}$  the value of your Social Security benefit.

**Social Security planning for you and your spouse can have significant positive impact on the benefits your son or daughter with a disability will receive:**

- The longer you wait to make the claim, the higher the benefits to you, and to your child with a disability.
- These Social Security benefits can become resources to help purchase services for your child.

## "COMMUNITY CONNECTIONS":

*Seguin Helps Former Jacksonville Developmental Center Residents Make the Most of Life in the Community*

In the past year Seguin welcomed 18 former residents of Jacksonville Developmental Center to residential services and employment and training programs. The Jacksonville facility was closed last year as part of Illinois Governor Patrick Quinn's "re-balancing" efforts, which are designed to reduce costs while providing excellent services to individuals with developmental disabilities in community settings. Through Seguin's "Community Connections" efforts, these 18 individuals now reside in Seguin's homes integrated into the community neighborhoods. They have their own bedrooms and decorate them as they desire, and help plan their own meals and their own social activities. Seguin has also provided them with opportunities for employment and life skills training, thereby increasing their self-esteem and self-reliance. In short, they are learning to make their own choices and enjoy life in a community setting, not an institution.
